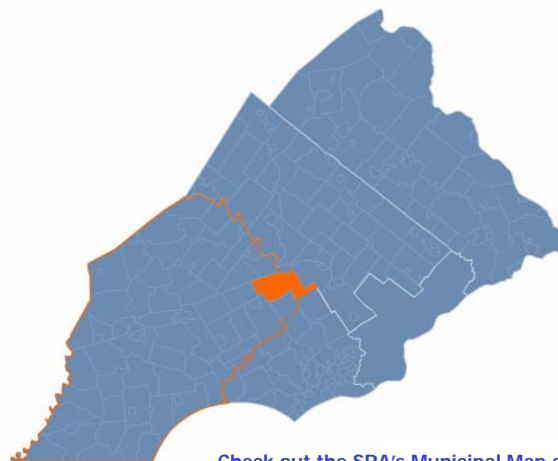
As a liaison between the real estate industry and public officials, we hope to work together to build our communities and ensure the availability of safe and affordable housing for all residents.
